ORDER

The above named complainant, a person with 50% locomotor disability vide his complaint dated NIL received on 07.09.2017 submitted that he is facing difficult to reach ZRO (C-1), Jhandewalan, Delhi as that office is approx. 30 kms. from his residence at Lajpat Nagar. He requested that he may be posted near his residence.

2. The complaint was taken up with the respondent vide notice dated 22.09.2017 and letter dated 30.10.2017. Vide letter dated 17.11.2017, the respondent submitted Action Taken Report and informed that a similar notice from Dy. Commissioner for Persons with Disabilities was received when the complainant was posted in Sarita Vihar Zone. Considering his request, he was surrendered by the Revenue Wing and he was posted with E.E (SDW), Kilokri vide Office Order dated 15.05.2017. After his promotion as ZRO, he was again posted in Revenue Department. After receipt of notice in this case, the complainant has been surrendered for further posting.



3. The complainant vide his letter dated 22.11.2017 informed that he had not yet been posted near his residence. Thereafter, a hearing was scheduled on 11.01.2018. During the hearing, the representative of the respondent submitted a copy of the Action Taken Report dated 05.01.2018 alongwith transfer order of the complainant to ZRO, WS, Malviya Nagar Water Services which is near his residence. The complainant confirmed that he has joined. However, he is still not close to his residence i.e. Lajpat Nagar. He further submitted that the incumbent at ZRO in Lajpat Nagar Office is due for retirement on 31.03.2018 and requested that he may be transferred when a vacancy arises.

4. In light of the action taken by the respondent, the complaint is closed and disposed off with the recommendation that as and when any vacancy arises in the office closer to his residence, the complainant may be considered for transfer in accordance with the instructions of the DOP & T in this regard.
