**ORDER**

1. Dr.Mahipal Singh Gandhi represented that he was not being sanctioned loan for purchasing a car by the state channelizing agency of National Handicapped Financial and Development Corporation (NHFDC). It was mentioned that the office of Delhi SC/ST/OBC/Minorities & Handicapped Financial Development Corporation the channelizing agency is not accessible and that there is a lack of basic facilities for persons with disabilities and therefore it is considered necessary to give appropriate directions to the concerned officers of the Corporation to put in place the requisite infrastructure to access the office without any difficulty.
2. On receipt of the representation relating to the case of Dr.Mahipal Singh Gandhi through Dr.Nitesh Tripathi the General Manager of the Delhi SC/ST/OBC/Minorities & Handicapped Financial Development Corporation was requested to file comments on the representation and since no comments were received even after repeated reminders hearings were held.
3. The Delhi SC/ST/OBC/Minorities & Handicapped Financial Development Corporation (DSFDC) sanctioned loan to Dr.Mahipal Singh Gandhi after seeking necessary

clarification and completing all the procedural pre sanction formalities that involve physical verification of the loan seeker obtaining documentary formalities. The National Handicapped Financial and Development Corporation was requested by the Delhi SC/ST/OBC/Minorities & Handicapped Financial Development Corporation to sanction the loan in favour of Dr.Mahipal Singh Gandhi. It was confirmed by the Deputy Manager of National Handicapped Financial and Development Corporation that the requisite loan for purchase of vehicle has been sanctioned to Dr.Mahipal Singh Gandhi. It is also considered necessary that the office of the Corporation should be accessible to the persons with disabilities in all respects for which action needs to be taken in a time bound manner and a report filed within three months i.e by 31.12.15.

4. The case is disposed of accordingly.
