ORDER

- 1. Dr.Nitesh Kumar Tripathi a disabled person represented that the provisions of the Persons with Disabilities Act are not being followed in the recruitment of faculties of the Medical College Hindu Rao Hospital North Delhi Municipal Corporation.
- 2. The Commissioner North Delhi Municipal Corporation was requested to file his comments on the representation and also on the other related representations which pertain to Rajan Babu Institute for Pulmonary Medicine & Tuberculosis (RBPT) and Girdhar Lal Maternity Hospital. Since no comments were received a hearing was held.
- 3. During the course of the hearing it was stated by the Director Hospital Administration North Delhi Municipal Corporation that a Roster Register has been prepared relating to reservation of post for persons with disabilities which has facilitated calculation of the backlog of the vacancies and that henceforth it would be ensured that appropriate

reservation is provided to the persons with disabilities at all levels as per the provisions of the Act and the instructions issued by the Government of India in this behalf.

4. I have perused the representation filed by the petitioner as well as the reply of the Director Hospital Administration North Delhi Municipal Corporation. In view of the assurance that reservation would be provided to the persons with disabilities in the recruitment of faculties of the Medical College Hindu Rao Hospital and in view of the Roster Register having been prepared for Hindu Rao Hospital it is expected that similar action will be taken by the Commissioner North Delhi Municipal Corporation for ensuring that reservation to the persons with disabilities is provided in all the institutions.

5. Ordered accordingly.
