Order

This office received a complaint through email dated 13.09.2017 from Dr. Nitesh Kr. Tripathi, a person with locomotor disability alleging that he has not been deputed for CME (Continuing Medical Education) to be held on 18.09.2017 merely on the ground of his disability and has thus been discriminated against.

2. A show cause notice was issued on 14.09.2014 why the complainant should not to be deputed for the said CME and to submit their version in the matter by 18.09.2017.

3. Although this court has not received a reply from the respondents, yet the complainant has informed the State Commissioner through Whatsapp message that he attended the CME held on 18.09.2017 and has received a certificate for the same. He however, has added that he had to face issues of accessibility to the venue.

4. In light of the above, the complaint is disposed off with the advice to respondent No. 2 to take early action to make the hospital fully accessible to persons with disability in accordance with the provisions in the Rights of Persons with Disabilities, 2016 and the "Harmonised Guidelines and Space Standards for Barrier Free Built Environment for Persons with Disabilities and Elderly Persons issued by Ministry of



Urban Development, Govt. of India in February, 2016 and submit a report within 3 months from the date of receipt of this order under intimation to the complainant.
