**ORDER**


1. Sh.Kaushal Kumar father of Master Abhay Aditya a disabled child filed an application stating that he was not getting the identity card for his disabled child issued from the office of the Sub Divisional Magistrate Model Town on the ground that his son has a disability of 40% as certified by the concerned notified authority and the identity card for disabled persons is issued only to a person who has a disability of 90% or more than 90%.
2. The Sub Divisional Magistrate Model Town was asked to file comments and since no comments were filed a hearing was held. During the course of the hearing a status report was filed stating **Quote** "Copy of request made by the applicant to the Commissioner (Disabilities) and the two notices issued to the SDM (Model Town) have been gone through. Unfortunately the notices could not be processed and the Commission has issued notice to the Divisional Commissioner for personal appearance on 6.10.15 at 10.00 AM. However the lapse was not intentional and was due to non availability of the application in this office and also the fact that the office of the DM (North) was being shifted during that time. Inconvenience caused to the applicant and the Commission is deeply regretted. As regards the issuance of identity card to Sh.Abhay Aditya it is submitted that this office has no issues regarding issuance of the Identity Card to the disabled on the basis of certificate issued by authorized Medical Board. Accordingly the

applicant i.e Sh.Kaushal Kumar father of Sh.Abhay Aditya has been telephonically contacted and asked to come to this office on 5.10.15 for issuance of Identity card for the disabled which is being issued by this office on the basis of certificate issued by authorized Medical Board. However the applicant showed some reservations on account of his personal engagements and he has been asked to come to this office on next working day or any other day of his convenience. In view of the above it is submitted that the grievance of the applicant has been sorted out and therefore it is requested that the Divisional Commissioner may be exempted from personal appearance.” **Unquote.**

3. In view of the action taken by the Sub Divisional Magistrate the case is closed.
