## **ORDER**

- 1. Ms.Priti D/o Sh.Bhanu Prakash resident of House No.860 F, Gali No.20, Shiv Kunj Sant Nagar Burari Delhi-84 a disabled person represented on 5.6.15 that she should be helped in getting admission in science stream in 11<sup>th</sup> class in either Government Girls Senior Secondary School No.1 Guru Teg Bahadur Nagar Camp, Delhi-9 or Savodaya Kanya Vidyalaya Nehru Vihar Delhi. And since the admissions would close on 14.6.15 there was a need to give directions to Director of Education on priority.
- 2. In view of the urgency in the matter a hearing was held on 11.6.15 which was attended by the Deputy Director North Directorate of Education who informed that it may not be possible to facilitate her in getting admission in science stream in a school under the Government of NCT of Delhi as her Cumulative Grade Point Average (CGPA) score is 6.2 which is less than the required score of 7 necessary for pursuing studies in the science stream. The Deputy Director further informed that the admission in science stream would have been allowed in case her scores were B-2 in all the subjects or even B-2 \* in one subject.
