ORDER

A complaint dated 25.06.2017 filed by Sh. Ghanshyam, on behalf of his daughter Ms. Sonam regarding difficulty in getting her Disability Certificate was received from Pandit Deen Dayal Upadhyay National Institute for Persons with Physical Disabilities (Diyangjan), Department of Empowerment of Persons with Disabilities (Diyangjan), M/o Social Justice and Empowerment, Government of India, vide letter dated 03.07.2017. The complaint was taken up with Guru Gobind Singh Hospital, Raghubir Nagar vide Notice cum Summons dated 21.09.2017 for a hearing on 04.10.2017.

On 4.10.2017, while the complainant /her representative did not appear, the 2. respondent informed that he did not receive copy of the complaint. He further informed that the Hospital contacted Ms. Rekha, a social worker and a date for assessment of disability of Ms Sonam had already been fixed on 16.01.2018. She would be examined, and if eligible, a certificate of disability would be issued to her.

- Ms. Sonam was examined by Disability Board of Guru Gobind Singh Hospital. She was diagnosed with Quadriparsis (spastic). The Disability Board advised that she should be sent for Neurological Assessment to Janakpuri Super Speciality Hospital. On enquiry from Janakpuri Super Speciality Hospital, it was learnt that her assessment had been done and on receipt of the same, disability certificate would be issued by Guru Gobind Singh Government Hospital.
 - 4. As there was no correspondence/ enquiry from the complainant, Ms. Rekha was contacted on the given telephone Number 9871381440 who informed that Ms. Sonam has been issued disability certificate and since the issue has been resolved, the case may be closed. Though she was requested to send an e. Mail or written communication to that effect, no response has been received till date.
 - 5. In light of the above, the complaint is closed and disposed off. However, if the complainant has any issue with regard to issuance of disability certificate she can bring it to the notice of this court.
