ORDER

- 1. The petitioner Dr.N.K.Tripathi a disabled person and resident of WZ-350, A/4 Ground Floor Gali No.19, Shiv Nagar New Delhi stated that the Delhi Jal Board is not implementing the provisions of Persons with Disabilities Act in the recruitment of General Duty Medical Officer (GDMO) (Grade-II) and requested that the concerned authorities should be directed to make recruitment as per the provisions contained in the Persons with Disabilities Act 1995 and also for giving directions for exemption to the disabled persons from payment of application fee, extra time during examination, age relaxation by at least 10 years, travel expenses to attend interview along with an escort and disabled friendly environment during interviews.
- 2. The representation was forwarded to the Chief Executive Officer Delhi Jal Board who informed that there are seventeen (17) posts of GDMO in Delhi Jal Board and as per the reservation roster one (1) post is reserved for persons with disabilities which has already been filled up by Dr. Vipin Prabhakar Verma who is a disabled person. Chief Executive Officer also informed that the provisions of the Act are being followed in letter and spirit and all other issues raised by the petitioner would be redressed/taken care of for ensuring justice to persons with disabilities.

- 3. A copy of the reply received from the Chief Executive Officer Delhi Jal Board was given to the petitioner who filed the rejoinder stating therein that the reply filed by the respondent that reservations and other concessions and relaxations as permissible under Rules were being given is misleading and that the respondent should allow the persons with disabilities to appear in the examination for selection of GDMOs even against unreserved posts.
- 4. During the course of the hearing Sh.Jainender Advocate for DJB alongwith Sh.Amit Jain Assistant Commissioner (Division) and Sh.Ravinder Kumar JLO DJB informed that the request of the petitioner would be considered favourably as and when there is a requirement of filling up the posts of GDMOs in DJB. In view of the assurance given by the representative of the DJB and in view of the fact that the mandatory reservation has already been provided by DJB to disabled person there is no need to pursue the matter further.

Ordered accordingly.
