ORDER

1. A representation was filed on 28.7.15 by Sh.Prem Avtar Sharma on behalf of his niece Ms.Vishakha a disabled person who was denied admission in Ahilya Bai College of Nursing. It was stated that the concerned officers of Ahilya Bai College of Nursing neither displayed the result on internet nor informed the selected candidates not even persons with disabilities through any other medium. Her name was displayed in 2nd admission list of persons with disabilities and there was no person with disabilities candidate in 3rd list. The last date of admission for 3rd list was 21.7.15. The petitioner met the Principal on 21.7.15 who informed him that the seat reserved for persons with disabilities had been given to a normal candidate since his niece did not come within the time limit fixed for the second list. The petitioner stated that as per provisions of the Persons with Disabilities Act it is her right to get admission in the seat reserved for persons with disabilities and prayed that directions should be issued for allowing admission to his niece on sympathetic ground in B.Sc Nursing as it is a matter of life of a person with disability.

2. Since the matter was of urgent nature it was proposed to hold a hearing by calling the Medical Superintendent of Ahilya Bai College of Nursing. It is a matter of satisfaction that a report was filed on behalf of the Principal of the College of Nursing Lok Nayak Hospital on 13.8.15 that Ms.Vishakha D/o Sh.Vishnu Dayal Sharma was given admission in B.Sc (Hons) Nursing 2015 on 6.8.15 and that she has been attending classes in the college since 7.8.15. In view of the action taken by the Principal of the College there is no need to pursue the matter further which is accordingly disposed of.
