ORDER

- 1. A petition was filed by Sh.Bankey Lal Prasad a disabled person and a founder President of Delhi Relief and Education Society for Handicapped relating to non payment of honorarium etc to the petitioner.
- 2. The Labour Commissioner Government of NCT of Delhi was requested to file his comments and since no comments were received a hearing was fixed. During the course of the hearing the representative of the Labour Commissioner stated that the petitioner alleged that a sum of Rs.12,000/- is due from Varun Beverages Limited and that his trolley was forcefully taken away by the agent of Varun Beverages Limited. The complaint was examined by the Labour Department and it was found that the complainant had entered into an agreement with Varun Beverages Limited to act as a vendor exclusively for selling

Pepsi brand products and therefore the petitioner is not a workman/employee and hence no action is warranted on his complaint by the Labour Department.

3. I have perused the petition and the reply filed by the Labour Commissioner. The petition is not maintainable in as much as the agreement with the Varun Beverages Limited clearly indicates that the petitioner was appointed as a vendor for selling Pepsi brand products and the petitioner was not an employee of Varun Beverages Limited and therefore the Labour Department is not legally empowered to intervene in the matter as it is a matter between two private parties through an agreement.

4. Ordered accordingly.
