## **ORDER**

- 1. Sh.Dan Singh a disabled person filed a representation stating that in the advertisement no.1/13 issued by Delhi Subordinate Services Selection Board for recruitment for the post of Staff Nurse no separate cut off list was published for persons with disabilities.
- 2. The representation was forwarded to the Chairman Delhi Subordinate Services Selection Board for filing their comments. Since comments were not received a hearing was held which was attended by the representative of the Health and Family Welfare Department Government of NCT of Delhi and the representative of the Delhi Subordinate Services Selection Board. During the course of hearing it was pointed out by the representative of the Board that Sh.Dan Singh the petitioner secured only 43 marks out of 198 marks in the written examination under post code 20/13 and 21/13 for the post of Staff Nurse. As per

the policy of the Board the minimum qualifying marks for selection as Staff Nurse for persons with disabilities is 30% and since the petitioner could not secure minimum qualifying marks he was not selected for the post of Staff Nurse.

3. I have carefully considered the representation of the petitioner and the reply filed by the representative of the Delhi Subordinate Services Selection Board (DSSSB) stating that the petitioner secured 43 marks out of 198 marks i.e around 21.7% marks in the written examination and therefore he could not be recommended for appointment as Staff Nurse by the Board. There is no ground therefore to pursue the matter further which is accordingly disposed of.
