ORDER

- 1. Sh.Jaipal Singh F/o Sh.Pawan Kumar Singh a disabled person filed a representation stating that his son who worked as Art teacher for about a year in Pramila Bai Chauhan Badhir Vidyalaya was not paid any salary and his services were terminated without giving any reason.
- 2. On receipt of the representation comments were sought from the Director Social Welfare. An inspection of the school was done by a Committee who could not find any documentary evidence of Sh.Pawan Kumar Singh having worked in the School.
- 3. A copy of the report received from the Office of the Director of Social Welfare Department was forwarded to the petitioner requesting him to submit documentary proof like photocopy of the application submitted by Sh.Pawan Kumar Singh to the School for

appointment as Art Teacher or any appointment letter issued to him by the School authorities. A hearing was also fixed. During the course of the hearing the petitioner reiterated the submissions already made by him. The petitioner did not submit any documentary proof/evidence in favour of his claim. Meanwhile a response was received from the General Secretary All India Deaf & Dumb Society stating that the recruitment in the School is made through advertisement in the newspapers by a Selection Committee. The petitioner Sh.Jaipal Singh had made a request that since his son was free at home and is feeling disturbed all the time he may be permitted to sit in the School for practicing painting and drawing. He was therefore permitted to sit in the School as a help to the hearing impaired persons. He used to come to the School off and on as per his own will. The complaint made by the petitioner is false and needs to be disposed of accordingly.

- 4. I have gone through the records of the case. It appears that Sh.Pawan Kumar Singh was not formally appointed to work as Art Teacher. He was attending the school as per an informal arrangement therefore he cannot claim that he was appointed by the School to work as Art Teacher. It is not possible to conclude by any stretch of imagination that Sh.Pawan Kumar Singh worked as Art Teacher in the School as there is no documentary proof found by the inspecting team nor was it produced by the petitioner even when he was specifically asked to do so. In conspectus it is not possible to support the case of the petitioner which is closed.
- 5. Ordered accordingly.
