ORDER

- 1. A representation was filed on 18.3.15 by Sh.Joginder Singh Saluja S/o Lt. Sh.Surinder Singh resident of 24-A, Pocket A Dilshad Garden a disabled person relating to unauthorised parking and also against locking of the main gate of the Colony thereby preventing free movement of vehicles etc entering /exiting the colony. It was alleged that the President of the Resident Welfare Association has been harassing the petitioner by creating obstacles in his free movement and also by calling him a disabled person which is not only insulting but also most unfortunate in a civilised society. The petitioner has been complaining to various authorities but to no avail.
- 2. In view of the nature of the grievance it was felt appropriate to hold a hearing at the earliest and accordingly a hearing was held on 24.3.15 which was attended by the Deputy Commissioner North Shahdra Zone East Delhi Municipal Corporation and the Assistant Commissioner of Police Seemapuri. It was informed by the Deputy Commissioner of East

Delhi Municipal Corporation that it would be ensured that there is no unauthorised parking and that the work of covering the drain would be got done in such a manner that the drain is covered by leaving sufficient gaps underneath to allow for free passage of water. This would also prevent unauthorised parking on the walking space. The Deputy Commissioner also assured that the unauthorised gate will be removed and in case there is a necessity of having a gate for security etc reasons the Resident Welfare Association would get it manned by a security guard round the clock to ensure free movement of vehicles. The Assistant Commissioner of Police Seemapuri assured that all possible care would be taken to ensure that the Rule of Law prevails in the area and the petitioner is not intimidated and threatened by anyone.

- 3. In view of the assurance given by the Deputy Commissioner Shahdra North Zone East Delhi Municipal Corporation and the Assistant Commissioner of Police Seemapuri it is hoped that needful would be done and the petitioner would not face any difficulty in accessing his residence in the colony.
- 4. The petition is accordingly disposed off.
