## **ORDER**

- 1. A representation was filed by Sh.Kishan Lal stating that his neighbour Sh.Ram Kumar who stays with his wife, son and daughter has been harassing him and abusing him and also told the petitioner that they would kill him. The petitioner requested the SHO of the Police Station to provide police protection from his neighbour.
- 2. After receipt of the representation Commissioner for Persons with Disabilities wrote to the Commissioner Delhi Police enclosing a copy of the petition and requested him to look into the matter personally and send an action taken report in a time bound manner and since no report was received from him a hearing was fixed.

- 3. During the course of the hearing the Respondent denied all the allegations made by the petitioner and therefore the matter was referred to the SHO Chhawla for further inquiry. The SHO PS Chhawla reported that the bone of contention between the two parties relates to their residential buildings etc and that they had been advised to settle their differences within the ambit of law and not to make allegations and counter allegations against each other. The petitioner and the respondent agreed that they would sort out the points of conflict between the two families in an amicable manner. The SHO PS Chhawla however was directed to maintain a vigil and take appropriate action to ensure that the petitioner a disabled person is not harassed in any way.
- 4. The matter is disposed of accordingly.
