ORDER

- 1. Sh.Mangal Singh Verma a disabled person filed the petition in this Court stating that he could not file an application under the category of Visually Impaired person as there was no column indicating reservation for Visually Impaired persons. The North Delhi Municipal Corporation however shortlisted him on 29.8.14 under SC Category. In the list issued on 3.12.14 the name of the petitioner was included in the list indicating the names of candidates who were not found eligible and the reason stated in the case of petitioner was the caste certificate from other State. Since the application/petition filed by Sh.Mangal Singh Verma was not clear a hearing was fixed and during the course of the hearing the petitioner stated that in case it was not possible to consider his case under the category of reserved vacancies for scheduled castes it should be considered under the category of disabled persons.
- 2. The representative of the North Delhi Municipal Corporation stated that the petitioner was not considered under the category of SC as he is not a SC from Delhi and as per the orders

of the Hon'ble Supreme Court of India only SC candidates from the Union Territory of Delhi could be considered for appointment in Union Territory of Delhi. In so far as the case of the petitioner under the category of disabled persons is concerned the only vacant post of Music teacher has been filled by appointing Mr.Anuj Saxena S/o Sh.Mahesh Saxena a visually impaired person with a weightage of 73.00%. The contention of the petitioner that the case of Mr.Anuj Saxena should have been considered under the General Category is not tenable as the cut off for the eligible candidates in the General Category is 76.09% and since the weightage of the petitioner is 69.98% it is not possible to consider his case.
