**ORDER**

1. A petition was filed by Sh.Nand Kishore working as Field Worker (Malaria Beldar) in Ward No.208, Sarita Vihar, Delhi stating that he had been transferred from the Office of the Anti Malaria Inspector in Ward 208 Sarita Vihar New Delhi to South Delhi Municipal Corporation Head Office Shyama Prasad Mukherjee Civic Centre which is more than 30Kms away from his residence in violation of the guidelines issued in this behalf by the Government of India.
2. After receipt of the representation a hearing was held. The representative of the office of the Commissioner South Delhi Municipal Corporation in the Health Department filed a photocopy of the office order dated 28.9.15 vide which the transfer order of the petitioner had been cancelled with approval of the competent authority.
3. It is observed that the grievances of the petitioner relating to the benefits available to the persons with disabilities like double transport allowance, special leave and special casual leave etc should be allowed as per the guidelines issued vide office memorandum no. 36035/3/2013-Estt.(Res.) dated 31.3.2014 by Department of Personnel and Training Ministry of Personnel, Public Grievances and Pensions, Government of India.
4. The matter is accordingly disposed of.
