## **ORDER**

- 1. Sh.Rameshwar Manjhi a disabled person filed a representation alleging misbehaviour by his supervisory officers of the Public Works Department Government of NCT of Delhi.
- 2. The Engineer in Chief was directed to file comments on the representation and since no comments were received hearing was held. The representative of the Public Works Department stated that Sh.Rameshwar Manjhi is working as a contractual employee through M/s Shaka Electrical (India) Ltd. for carrying out E & M maintenance work of Delhi Technical University and that the Public Works Department had not hired any man power directly. M/s Shaka Electrical (India) Ltd. had provided wireman, khallasi and operator to carry out maintenance work in Delhi Technological University. The Khallasi/Helper has to carry out the duty of keeping installation neat and clean helping skilled labour in execution of work and since Sh.Rameshwar Manjhi is a disabled person only light duty work of Khallasi category for keeping installation neat and clean has been entrusted to him and he is not being asked for carrying out work like carrying the ladder and any heavy T & P equipment. No officer of the Department has at any time used any unparliamentary language against Sh.Rameshwar Manjhi and that there are other persons

who are also being provided as a Helper/Khallasi by the contractor and they are performing their duties without any grievances. The representative of the Department further added that Sh.Rameshwar Manjhi is very insincere and remains absent during duty hours and the Contractor has given instructions to Sh.Rameshwar Manjhi to work as per rules without any complaint from the Department. Sh.Rameshwar Manjhi is in the habit of making unnecessary and irrational allegations against any person who asks him to do the work sincerely. The contention of Sh.Rameshwar Manjhi is baseless and denied by the Department.

- 3. I have carefully considered the representation of the petitioner and the reply filed by the representative of the Public Works Department and I am of the view that there is a need for the petitioner to work sincerely. The officers of the Department should be reasonable in dealing with all personnel and maintain cordial working atmosphere. The supervisory officer in this case namely the Assistant Engineer assured that they would not ask the petitioner to do any work of a nature which is not convenient for the petitioner to carry out and that he would be given light duties which he should of course perform sincerely. In view of the assurance given by the Assistant Engineer of Public Works Department there does not seem any ground to pursue the matter further which is accordingly disposed off.
- 4. Ordered accordingly.
