ORDER

- 1. A petition was filed by Sh.Sachidanand a disabled person working as TGT Hindi on contract in Government Senior Secondary School for Blind Boys Sewa Kutir Kingsway Camp under the Department of Social Welfare stating that all the teachers appointed on contract basis in the school are not being paid salary as fixed by the Directorate of Education vide circular dated 8.10.2010 and not as per the rates revised by Directorate of Education vide circulars dated 25.6.13 and 30.9.13.
- 2. The representation was forwarded to the Director of Social Welfare for filing comments however since no comments were received hearing was fixed in the matter. It was assured by the representative of Director Social Welfare during the course of the hearing that the teachers appointed on contract basis will be paid as per the rates notified vide circular dated 8.10.10 and the rates would also be revised in consonance with the rates notified vide circulars dated 25.6.13 and 30.9.13 after taking approval of the Department of Finance Government of NCT of Delhi.

3. In view of the assurance given on behalf of the Director Social Welfare of Government of National Capital Territory of Delhi the matter is disposed off with an advisory that the Director of Social Welfare should look into the matter personally and ensure that the assurance given in the Court is fulfilled in a time bound manner.
