ORDER

- 1. A representation was filed on behalf of Sh.Yamuna Prasad Gupta a visually impaired person working as TGT in Government Boys Secondary School Burari. It was informed that Sh.Yamuna Prasad Gupta the petitioner admitted his mother in Max Hospital Delhi an empanelled hospital under the Government of NCT of Delhi and paid a sum of Rs.2,38,500/- for surgical treatment. The Department however refunded only Rs.1,49,250/-. It was requested that the balance amount of Rs.90,000/- should be paid by the Department to the petitioner.
- 2. A notice was sent to the Directorate of Education and since no comments were received from the Directorate of Education Government of NCT of Delhi a hearing was fixed. The hearing was attended by a representative of Directorate of Health Government of NCT of Delhi and Deputy Medical Superintendent of Max Hospital Saket (Devki Devi Foundation) alongwith Senior Manager (Legal). It was stated by the petitioner that the concerned doctor of the Max Hospital had informed him about the cost of stent to be implanted however the amount in the final bill was more than what was stated before the surgery. The Deputy Medical Superintendent of the Max Hospital however stated that the

petitioner had been duly informed about the actual cost of the stent there is however no written record available as to the nature/type of stent to be used and the cost there of.

3. In view of the facts of the case the petitioner was given the benefit of doubt and the Deputy Medical Superintendent was gracious enough to give a cheque of Rs.89.250/bearing no.552957 of IndusInd Bank in favour of Sh. Yamuna Prasad Gupta the petitioner. In view of the payment made to the petitioner there is no need to pursue the matter further which is accordingly disposed of.
