ORDER

- Dr. Yogesh Tekwani, a person with 52% locomotor disability vide his complaint dated 31.03.2017 inter-alia submitted that he was being threatened by the then M.S., Babu Jagjeevan Hospital and Dr. Jagriti Bhagora Medical Officer.
- 2. The complaint was taken up with the respondents vide notice dated 06.06.2017.
- 3. Upon considering the reply of the respondent and rejoinder of the complainant, the parties were heard on 23.10.2017, 21.11.2017 and 14.12.2017. On the last date of hearing on 14.12.2017, the representatives of the respondent submitted a letter dated 13.12.2017 of Dr. Pratibha Nanda, Medical Superintendent vide which she submitted that she was trying to persuade Dr. Jagriti Bhagora and the

complainant to settle the matter amicably and both have agreed to withdraw their respective complaints. She requested for more time. As the complainant had no objection to that though he felt insecure, the request of the respondent for more time was allowed upto 29.12.2017. The parties were advised to intimate the outcome of the settlement vide Record of Proceedings dated 19.12.2017.

- Dr. Pratibha Nanda, Medical Superintendent vide letter dated 04.01.2018 4. informed that the matter has been resolved amicably by Dr. Yogesh Tekwani and Dr. Jagriti Bhagora and they have submitted in writing that they did not want any further action in respect of their complaints. Copies of written submissions of Dr. Jagriti Bhagora and Dr. Yogesh Tekwani were also enclosed. Dr. Jagriti Bhagora has submitted that in order to maintain cordial relations among staff and in the interest of patient the complaints given by Dr. Tekwani against her and her complaint against She requested the Medical Dr. Tekwani have been amicably resolved. Superintendent to consider her complaints as cancelled and no further action is required. Dr. Tekwani vide his letter dated 3.01.2018 has submitted that he wants to cancel his complaint against Dr. Jagriti Bhagora as she has also withdrawn her complaints against him. He has also mentioned that in case Dr. Jagriti Bhagora goes back on her written statement, his complaint may be revived.
- 5. 44 In the light of the submissions of the parties and their undertakings, the complaint is closed. It is however, made clear that the complaint of Dr. Yogesh Tekwani which he has cancelled, would not be revived as he has option to file fresh complaint in case of any harassment on the ground of his disability.

The matter is disposed of accordingly. 6.
