ORDER

The above named complainant, a person with 60% locomotor disability vide his complaint dated 13/02/2019 submitted that DSSSB had advertised for filling up 73 vacant posts of PGT English- Male (Post code 108/17). In the said advertisement two vacancies were reserved for persons with disabilities i.e OH-01 and VH-01. Result was declared by DSSSB and the cut off for PH (OH) category was 123. The complainant scored 129 marks with Roll no. 2080004195. He also submitted that no candidate of OH category had been selected and the reserved vacancy of OH category was left unfilled.

2. The complaint was taken up with the respondent vide notice dated 19/03/2019.

3. The respondent vide reply dated 06.05.2019 submitted that as per advertisement No.04/2017, one post under PH/OH category was notified against which 07 candidates were shortlisted including the complainant. The last candidate provisionally nominated under PH/OH category scored 151.00 marks whereas Sh. Ravi Datt scored 129.00 marks. In the result notice No. 315 dated 14.12.2018, the category has been inadvertently mentioned as

PH/VH category instead of PH/OH category and a corrigendum to this effect has been issued vide letter dated 06.05.2019.

4. An email dated 15.05.2018 was sent to complainant to submit his comment if any by 17.05.2019. No communication has been received from complainant till date. In the view of this, the complaint is disposed of.
