**ORDER**

The above named complainant, a person with blindness in his complaint dated 19.02.2018 submitted that he applied for the Post of PGT (Hindi) in 2012 and his Roll No. is 22000044. When Delhi Subordinate Services Selection Board (DSSSB) declared the result in 2017, he could not see his result as he did not have a login id and nobody in DSSSB helped him to create a login id. As a result, he does not know his result.

2. The complaint was taken up with the respondent vide letter dated 06.03.2018 and reminder dated 27.04.2018. As there was no response, a hearing was scheduled on 28.06.2018.

3. During the hearing on 28.06.2018, the complainant stated that he applied for the Post of PGT (Hindi) Post Code 136/12 offline in 2012. The pre exam was held on 29 November, 2014. The main exam was held in June, 2015. The said examination was cancelled and its main exam was again held in June 2016. The result of the said examination was declared in October, 2017. However, as his mobile no. 9369022920 was stopped by the Company, he could not create login id and see his result. As nobody in DSSSB helped him to create a login id with his new mobile no. 8882137941, he is not aware about his result even today. The complainant requested that he should be informed about the result of the exam for the post of PGT (Hindi) post code 136/12.

4. Chairman, DSSSB was advised to instruct the concerned officer to submit the status of the result of the complainant for the post code 136/12 by **09.07.2018** and appear before the State Commissioner for Persons with Disabilities on **17.07.2018 at 12:30 pm** and intimate the result to the complainant at his email Id i.e. [santoshbanda1980@gmail.com](mailto:santoshbanda1980@gmail.com).

5. The respondent vide letter dated 28.06.2018, received on 04.07.2018, informed that Sh. Santosh Kumar having Roll No. 22000044 obtained 85.5 marks out of 250 for the post of PGT (Hindi) under Post Code 136/12. One vacancy in the said post was reserved for persons with visual impairment. Sh. Rohit having Roll No. 22000047, who obtained 152.25 marks, was selected for the said post. The complainant was not selected as he had secured less marks than

the selected candidate. During the hearing on 17.07.2018, Sh. Ajit Kumar, Deputy Secretary, DSSSB also produced a copy of the Result Notice No. 596 dated 16.02.2018 for Post Code 136/2012 indicating the result in respect of Visually Impaired category also. He clarified that the said result was in the public domain and the complainant could have accessed the same from the website of DSSSB. He also submitted the list of 7 candidates with visual impairment who had secured above the minimum qualifying marks. It is seen from the said list that the complainant with 85.5% marks is the 7<sup>th</sup> candidate against the single vacancy reserved for visual impairment.

6. In the light of submissions of the respondent and the relevant record, the complaint is disposed off. DSSSB may, however, consider making appropriate arrangement for guidance and redressal of grievances of candidates with disabilities to avoid prolonged litigation
