- 4. Department of Social Welfare, Govt. of NCT of Delhi vide letter no 41(59)/FAS/DSW/Misc./2010-11/Pt-I/Vol-I/17971 dated 10.10.2019 submitted that disability pension of Rs. 42,500/- has been released on 30.09.2019.
- 5. In view of the fact that the complainant has got the relief, the complaint is disposed of.
