ORDER

Whereas Sh. Deepak Sharma f/o Ms. Jiya Sharma, a person with 75% intellectual impairment filed a complaint dated 09.12.2019 the complainant alleged that he applied for disability pension in respect of his daughter vide application no. 26040000019794, registration I.D. 102221402 on 31.12.2018. But till date the pension had not been sanctioned.

2. The complaint was taken up with the respondents under the Rights of Persons with Disabilities Act, 2016, hereinafter referred to as the Act vide

show-cause-cum-hearing notice dated 19.12.2019 directing the respondents to show cause why disability pension should not be released to the complainant and to submit para wise comments by 27.12.2019. In case, the same was not done by the said date, the respondents were directed to be present for a hearing on 28.12.2019.

3. Sh. Pankaj Kumar Verma, District Officer (Central) appeared on 27.12.2019 a day before the date of hearing and submitted letter no. F-4(47)/DO-C/DSW/19-20/857 dated 27.12.2019, which read as under:

I. Application of Ms. Jiya Sharma d/o Sh. Deepak Sharma r/o T-29/4A, Baljit Nagar, Road No.20, Near West Patel Nagar, Delhi-110008 was received on 31.12.2018 through web portal under application no. 26040000019794.

II. The dealing assistant has scrutinized the same application on 20.01.2019 and forward to competent authority as verified. The same application was approved by the competent authority on 20.01.2019 and digitally sanctioned on 21.01.2019 as a result the case had been automatically forwarded to Deputy Director (FAS), Deptt. of Social Welfare, GNCTD for further necessary action (copy enclosed). As per record of this office, your financial assistance was returned back due to invalid account. The details are attached for your kind information.

III. It is also submitted that the same procedure was done within stipulated period as per notification. The details of the same are being attached for your kind information. An email is being sent to DD(FAS), Deptt., of Social Welfare, GNCTD to release the same case's financial assistance as on priority basis.
