Relaxation in Upper age limit in respect of children with disabilities for admission to entry level classes.

Sir.

As per the guidelines for admission of EWS/DG and children with disabilities to entry level classes in private/ unaided/ recognized school of Delhi for the academic session 2019-20 issued vide circular no. DE15(577)/PSB/2018/326-332 dated 11.01.2019, the age limit as on 31.03.2019 is as under.

Class	Age limit as on 31.03.2019
Pre-School/Nursery	3-5 years
Pre-Primary/KG	4-6 years
Class-I	5-7 years

2. Many children with disabilities for a variety of reasons such as delayed development, learning disabilities, availability of appropriate school, etc. do not become school-ready or can not take admission at the age, the other children do. Directorate of Education relaxed the age for admission of children with disabilities at entry stage up to 9 years vide circular No. DE40(20)EVG/IEDC/Circular/98/7109-8699 dated 06.01.2003. It valid in 2017 also as per order No. F.265/DDE(IEDSS)/Admn.Cell/2017-18/2609-2613 dated 11.09.2017.

- 3. In view of the above, it is recommended that all the government/government aided or government recognized schools in the National Capital Territory of Delhi be directed to relax the upper age limit up to 9 years for admission to entry level classes in respect of children with disabilities. A corrigendum to the circular dated 11.01.2019 may please be issued and online module be also appropriately modified to avoid inconvenience to parents of such children with disabilities.
- 4. It is requested that copies of circulars/orders relating to admission/ education of children with disabilities may be marked to the office of State Commissioner for Persons with Disabilities also.

Class-I	5-9 years
